**PLEASE READ BEFORE SIGNING  
Agreement & Understanding**

To borrow a bike, riders must be 18, able to provide valid identification and a \$10 refundable cash deposit. The bike must be returned within 24 hours or the deposit will be forfeited and the bike may be reported as stolen. It is understood that the user of the bike is physically fit, sufficiently skilled in bike riding and able to participate in strenuous activity. To ensure user safety, the user must wear a helmet, ride with traffic, single file on the right side of the road or in designated bike lanes, obey all rules of the road, maintain a safe bike speed, lock up bikes when not in use and may not carry children on the bike. Bikes must be ridden in daylight only, on paved surfaces. In case of emergency please call 911. Trail maps are available for a \$1.00 donation

Before renting the bike, the user should be certain the bike and helmet are a good fit and are in good working condition. User's acceptance of the equipment is on an "as is" basis. If a bike has a mechanical problem, the user is expected to bring it back to the designated distribution center and report the problem.

By signing below, I agree to and understand all the terms mentioned above and verify all the information about me that follows is correct and valid.

**Simsbury Free Bike Indemnification Agreement**

It is expressly agreed that the use and/or operation of any Simsbury Free Bike and Children and Adult Mobility Project, Inc. hereinafter referred to as "SFB" and "CAMP" bicycle and equipment by the undersigned (hereinafter referred to as "user") is at the user's sole risk and the user assumes any and all risk from the use and/or operation of any SFB or CAMP bicycle and equipment.

I, for myself as releasor and anyone entitled to act on my behalf such as heirs, executors and administrators, do hereby agree to release, hold harmless, and discharge releasees, their affiliates or successors, including SFB or CAMP and its directors, officers, and representatives (including but not limited to any distribution centers, such as **Mill Commons** boards, trustees, officers, owners, and employees) from any and all claims and liabilities of any kind arising out of my use or operation of any SFB or CAMP bicycle or equipment even though that liability may arise out of negligence, recklessness, or carelessness on the part of persons or entities named in the Indemnification Agreement.

Now therefore, in consideration of the free use of the aforementioned bike and equipment provided by Simsbury Free Bike as a community service, I, the undersigned, agree that should any person become injured or any property damaged while I am contractually responsible for the bike or equipment, I further agree to indemnify and to hold harmless SFB and CAMP and its directors, officers, and representatives (including but not limited to any distribution center, such as **Mill Commons** and its boards, trustees, officers, owners, and employees) for any and all liability, loss, damages, cost or expense, including attorney's fees, that they might incur or be required to pay by reason of such injury or damage.

**I have voluntarily read and understand this Indemnification Agreement in its entirety voluntarily and knowingly sign it.**
